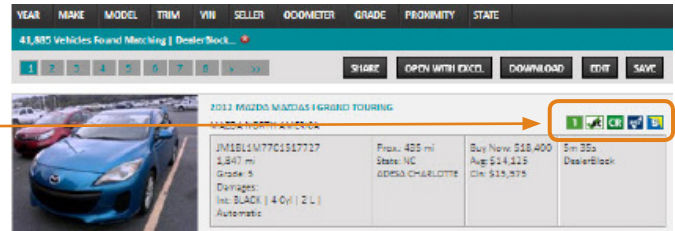


WHAT DOES THE ICON MEAN?

Ever wonder what all the icons mean on the Search Results Page?

These icons signify important vehicle information that are available to you at a glance.

Below is a list of all icons used for vehicles on ADESA.com



Icon	Name	Description
	First Run	This vehicle is in its first auction iteration.
	Last Run	This vehicle is in its last scheduled iteration.
	Promotion	A promotion or incentive is attached to the sale of this vehicle.
	Open = Reserve	The opening bid equals the reserve price set by the seller.
	Pre-Delivery Inspection	A Pre-Delivery Inspection is available for purchase.
	Post Sale Inspection	A Post Sale Inspection is available for purchase.
	Price Reduced	The Open, Reserve or Buy Now price has been lowered from the previous iteration.
	AutoCheck	There are no vehicle history report exceptions and no discrepancies.
	AutoCheck	This vehicle has vehicle history report discrepancies but no exceptions.
	AutoCheck	This vehicle has vehicle history report exceptions and may have discrepancies.
